To the Members of the Howell Township Planning Commission,

I am writing to express my strong opposition to the proposed zoning change from Agricultural Residential (AR) to Research and Technology (RT) for the property currently under consideration for development as a data center.

Our township's AR zoning was created to preserve farmland, open space, and the rural character that defines our community. Replacing prime farmland with an industrial-scale data center is not consistent with that vision.

A data center poses several risks and negative impacts:

- Noise pollution from large-scale cooling equipment running 24/7.
- Loss of farmland and rural heritage, permanently changing the landscape of our community.
- Utility and infrastructure strain, including massive electrical demand and potential water usage.
- Decreased property values for nearby farms and residences due to the incompatibility of industrial development in a rural setting.
- Dangerous precedent, opening the door for more farmland to be converted to industrial use, eroding our township's agricultural identity.

While we understand the desire to bring economic development, a data center is not an appropriate use for this location. The long-term costs to our community far outweigh any shortterm financial gain.

I urge the Planning Commission to deny this zoning change request and to uphold the original intent of Agricultural Residential zoning: protecting our farmland, our quality of life, and the rural character of Howell Township.

My husband and I recently became aware that the township is meeting tomorrow afternoon to vote on rezoning certain areas in Howell in order to allow a large datacenter to be constructed in the area. We will attend the meeting but wish to voice our opinion (via email) AGAINST allowing this zoning change to happen!

Both of the proposed areas for the datacenter(s) are within one mile or less of our rural / ag residence. We are very concerned about the negative effects that the construction and running of a huge datacenter that close will have on our quality of living here. We are appalled at the lack of research and transparency that is available to the public regarding such a large construction. In learning about what these large buildings/ businesses require in terms of resources (huge amounts of water and electricity, namely) we are concerned about the stresses to those resources in our area! Exactly who is shouldering the cost of this construction and the pressure on the water and electric infrastructure?

There is precedence for this. In other states where datacenters have been built and are running, people living nearby report horrible things that have happened to their once quiet country neighborhoods as a direct result. Water tables and aquifers drained, affecting homeowner's wells and plumbing; construction noise and dust and debris; loud humming noises constantly; light pollution; displacement of wildlife; doubling of electric bills -- all without direct benefit to the area residents or schools, or evidence of promised "jobs". We have no desire for this to be a part of our community!

We moved to the outskirts of Howell 25 years ago. Aside from living close to a mildly noisy airport, it has been a beautiful and peaceful place to live. We feel that if these datacenters are allowed to take hold in Howell, this quality of living that we all enjoy here will be ruined. 

My name is Marie Walker and I am a Howell Township resident. I am writing to you today regarding my opposition to the proposal


to rezone property from Agricultural Residential to Research and Technology in our community.

Dear Zoning Administrator,

I am writing to you in STRONG OPPOSITION of the potential data center that is to be voted on tomorrow night (9/23) which will sit on beautiful farmland owned by the Van Gilder family.

Here are my concerns regarding this data center:

The negative economic impact far outweighs any positives this data center may bring. Yes, it may employ a handful of people (who probably are too specialized to even live in this area). But my larger concern is the potential to deplete our aquifer by consuming 1-3 MILLION GALLONS of water PER DAY. How will this impact the homes and businesses nearby who depend on this aquifer to provide them with clean drinking and bathing water? How will they taint the drinking water by pumping into their system and then discharging it into the aquifer?

There are promises of it bringing tax revenue to the township, however previous data centers across the country have shown otherwise. Communities who've already been invaded by these centers have been left holding the bag when it comes to grid and infrastructure improvements as well as long term impacts to the community. It has been shown that big tech negotiates tax abatements and exemptions meaning that very few dollars actually flow through the community to benefit from it. I am also very concerned about what this will do to our electricity bills. They have already risen 150% from this time last year. What will our bills look like after the data center maxes out the power grid in this area and then further infrastructure improvements are required to be completed all on the tax payers dime?

These giant buildings are also an eye/ear/and soul sore on the character of this community. These are not pretty buildings with nice greenery outfront, they are sprawling industrial warehouses with round-the-clock mechanical hums, rooftop cooling fans and LOTS of truck traffic. Videos of data centers in lowa and Virginia show residents experiencing a CONSTANT low-frequency hum that travels far beyond the property line. Howell Township is a legacy farm community - replacing beautiful productive land with 500 ft long metal boxes forever changes the character and landscape of our quaint community.

Thank you for your consideration and I certainly hope when you make this decision, you will keep in mind the residents who call this beautiful place home.

My name is Kayla Lyons. I would prefer to attend the rezoning meeting in person, but my children will be playing Baseball in Howell from 6-7:30pm. Please review my comments below.

My family moved to Livingston County one year ago, after living in Orlando, FL. Being raised on a farm in a rural Michigan community similar to Howell, I know the importance of maintaining farmland to feed the world.

Although our address is Brighton, we live right near the border of the school district not far from Three Fires Elementary. Our pediatrician is located in Howell, our children play baseball in Howell, and we frequent restaurants in Howell several times a month.

The importance of maintaining farmland and the opportunity for single-family homes to be built is what keeps the small-town appeal of Howell. Should the rezoning be approved it would be the beginning of the end for the rural feel of the community, not to mention an potential increase in electricity costs passed on to residents.

It is no secret that data centers draw tremendous amounts of water, which could lead to the drying of wells in surrounding areas. Many of the homes here still operate on a well. Additionally, the electricity these centers draw are monumental. Local residents are already seeing an increase in monthly bills from DTE and power outages during winter storms. There is no telling what the shift in priority will be should a corporate, big tech data center be the new kid on the block. Sure it might bring temporary construction jobs and be a tax money influx, but the long term effects do not outweigh these to the local residents. There is no going back if the rezoning is approved.

Unless it is determined that the data center would have to run off of a sustainable operation, such as solar or wind power, I don't think it's a good idea to consider it at this time.

We must protect our Great Lakes and smaller bodies of water. I urge you to <u>review this article from the Environmental and Energy Study Institute</u> regarding the water consumption to operate a data center.

The influx of jobs during the construction phase do not outweigh the lack of jobs for daily operation of a data center. After a quick search on reddit seeking real experiences of employees of other data centers, it is shared that an estimated employee ratio for a 48 MegaWatt Data Center is approximately 28 full time employees for daily operation - all others being vendors coming and going.

Please reconsider the potential zoning change. This is not a good idea. I prefer my well not to dry up due to the expected water usage for cooling.


I urge the township to carefully consider these factors and to seek input from local residents before moving forward with any zoning determinations. Our community's well-being and sustainability should remain the top priority.

Dear Members of the Howell Township Board and Planning Commission,

My name is Marcus Chidester and I am a lifelong Howell resident and recent Northern Michigan University Graduate from the Construction Management program. Additionally, I work for a top 25 General Contractor in the US that is based out of Michigan; I hope to bring the perspective of a citizen as well as a construction professional. When I initially saw the proposal for this project, the first thought that came to my mind was to gather as many *facts* as I could to make an informed decision. What I am voicing in the below points are all *facts* based on my experience and education in the construction industry; I am not here to argue about things I am not truly informed on. So please, review my thoughts from the perspective that you are in this position to represent the people of Howell Twp. and the surrounding area.

Jobs

Undoubtedly, one of the largest "pro's" of this project is the "thousands" of jobs that it will generate for our community. However as a construction professional, I know that number is incredibly misleading. My employer is actively building a data center in the Philadelphia, PA area and in order to do so, they did not employ "locals" to manage the construction; they brought in "Mission Critical" experts from throughout the country to work on the project. This is not atypical, whether it is Turner, Christman, Barton Malow, Hensel Phelps, or any other large GC, they are essentially importing talent throughout the country for the duration of the project, to simply ship them back out after the completion.

From a trade labor perspective, you are not creating Livingston County jobs by allowing this project to happen. In Michigan's market, on a project this size, I can say with 90% certainty that this will be a Union built job. Sure, there are union tradespeople living in Howell, but there are no Howell Union "Locals". This means you will be bringing in workers from Lansing, Detroit, Ann Arbor, and Grand Rapids "Locals" to build this project. Aside from a stop at the gas station and a sandwich from lunch, I do not see how this significantly impacts our local economy in a positive manner. These workers are not buying property in and around our cities, they are simply driving to work, putting in 8-10 hours, and driving right back home. In fact, if I were to ask most of the workers on the jobsite I'm currently on, most would prefer to **not** stay in the town they work in.

At the end of the day, if you *truly* believe that this \$1 Billion+ project is worth 50 full-time jobs then I would love to hear your explanation for that. In reality, if *all* you are looking for is job creation, a Texas Roadhouse would more than double that number.

Data Center Day-to-Day

Having connections to former classmates and colleagues who have previously or are currently working on Data Center construction, I have a few alarming truths about what this complex would bring to our community. We have both seen plenty of numbers thrown around regarding water and power usage, however I am concerned about what the **reality** of this project brings to Howell Township and the surrounding areas. My foremost concern is the noise that will be produced by the data center. In my conversations with a Superintendent(I will keep him anonymous) managing the construction of a data center in Philadelphia, I asked what the realistic noise pollution from this facility would look like and I was told that "anyone within about 3 miles would be able to hear the equipment running, anyone else would be okay." For reference, 3 miles extends from the project site into downtown Fowlerville and to the Howell Airport. Is this an acceptable compromise for the *hope* of some contribution to the community from the developer. What are the people within those 3 miles supposed to do? Are we expected to simply turn a blind eye and change our lifestyles to accommodate this noise pollution?

Now lets say the noise issue goes away, another set of issues that arise are what this facility would do to the communities utilities. I am aware of the MHOG letter and I'm sure DTE can accommodate the power needs, MHOG even mentions upcoming upgrades to their facilities, but who is funding these upgrades? I know the answer and so do you, it's **the people** of Howell Twp. and the surrounding areas. At that same data center in Philadelphia, significant upgrades were required to the electrical grid and in order to make enough power to operate the data center the local residents' electrical bills were raised 11%. Help me make sense of that. With the expectations of similar upgrades being needed for this proposed project, what will **the people** see? Our capacities are nowhere near those of Philadelphia, PA, so what would our electric and water bills look like? A key issue with that question is that you cannot answer it, not by your own fault, but simply because if you look at other projects throughout the country the same thing pops up everywhere. Why do they do this? Because nobody can stop them. If they raise our bills and taxes, a group of hard working individuals from Livingston County stand no chance against Meta in a Court of Law.

I get that this isn't an academic source, but according to posts by Trustee Bob Wilson, an academic paper written by UM Undergraduate students with the assistance of faculty with Harvard education is simply hearsay. At this point, I do not know what else I can offer you; Harvard education or not, the people that build these facilities know better than any other source you can ask for. I welcome you to reach out to me if you would like to verify the validity of anything I have said.

Conclusion

In closing I would just like to leave you with a couple of statements that should serve as thought provoking and intuitive as to why we do not need this in our community. First, our community has proven time after time that they are willing to put their tax dollars forward to benefit the things they care about most. When was the last time a school bond in this area didn't pass? Fowlerville and Howell have both passed school bonds in recent years; those things didn't happen at the hands of a corporation, the people made it happen. Corporations like Meta don't just land in a town like Howell out of chance. They fish throughout the country to find whoever is willing to bite on their proposal on the promise of a couple bucks. When their proposal gets denied(like Saline), they just move on to the next one until they finally get what they want. In this case, the Van Gilder family are the ones who bit on the opportunity to make their pockets a little fatter based on false promises. So again, before allowing the identity of Howell and Fowlerville to forever be changed by this project, reflect on the people of our community that work hard to make this community so strong; is this truly in their best interest? People have always and will continue to live in Howell and Fowlerville because of the idea of living their lives in a small, safe community; not with the hopes of their everyday lives being impacted by individual wealth and corporate greed. Should you choose to move forward with allowing this project, I encourage you to release a statement to the public stating exactly what this is; a prioritization of industrial development and corporate avarice over the people who elected you to your position.

I am writing to express my views about the proposed zoning change to allow the development of a major datacenter in Howell Township.

I am a resident of Marion Township, but I view this proposal as having a major impact on the entire region, and therefore feel compelled to offer my opinion. The dependence of such a proposal on the MHOG distribution of massive amounts of water depends on the aquifer here in Marion Township and directly impacts the wells on my own property. The reassurances offered by the applicant are contradicted by the wealth of experience in other communities in which such promises and reassurances were later proved wrong. The unused "capacity" should remain for the benefit of our residents, not for profits of the billionaires in the AI industry.

Similarly, evidence regarding "community benefit" from the increased jobs, tax base, etc., all face examples of communities who found such promises did not accrue as planned. Instead, communities describe regret, increased costs, infrastructure demands, health problems (noise, light, traffic, pollution, etc.)

I have reviewed Howell Township's Master Plan. Similar to the Master Plan endorsed in my own township, the plan emphasizes maintaining open spaces, supporting preservation of agricultural land, and the preeminence of low density residential spaces. Despite the applicant's language to the contrary, the proposal is absolutely contrary to the goals which your Commission and Board committed to. Your residents and neighbors do not benefit from such a project and stand to be substantially harmed. I can't accept the applicant's assertion that community benefit outweighs the harm to immediate neighbors, and examination of examples in other communities illustrate this over and over again.

Across the United States, and within Michigan, we have lost enormous acreage of productive farmland to the various pressures of development, commercial, industrial, and residential. Livingston County has important contributions to Michigan's agricultural heritage. I point you to The American Farmland Trust for details about these trends in our community. In my own small way, I am trying to preserve the piece of land that is my farm, settled in the mid 1850s and remaining in production to this day. If we don't collectively support keeping agricultural land in production, and resist the industrial development of arable lands, we will be unable to support the needs of our society for food and other agricultural products. We then become dependent on imported goods the quality of which is not under our oversight or control. We cannot let this happen. Howell Township's Master Plan seems to recognize this as a value, and implies the necessity to resist this zoning change in order to support our collective self-sufficiency in the food supply.

Such projects have been undertaken in other communities similar to ours. Please study this matter in detail within those communities. What I see as a consequence of datacenter development in rural areas is the total transformation of communities that bought the promises of the industrial sponsors and later found that they were used, sacrificed, and harmed for profit. Please don't let this happen in our community.



I live at 1400 W Marr Rd and I'm writing to voice my **strong opposition** for the rezoning of the land listed as Agricultural Residential (AR) to Research and Technology (RT). Rezoning this land would go against the vision and goals of the 2023 Howell Township Master Plan. According to the Master Plan, "the preservation of open space and community character is of primary importance to the quality of life in Howell Township" and "88% of survey respondents indicated that the preservation of farmland and providing support for agricultural use was important or very important." The Future Land Use map in the Master Plan identifies the land in question as Agricultural Preservation, highlighting the importance of this tract of land. The planning commission should consider whether this rezoning supports the master plan for the township and the vision supported by its residents.

Furthermore, there has been a lack of sufficient information available on the intent of this rezoning. If a data center is to be the planned use for this land, I strongly urge the planning commission to consider the negative impacts of a data center. Data centers are well known to have a significant environmental impact, locally and globally. Data centers require incredible amounts of water for cooling, significantly impacting on our local water resources. A data center directly opposes one of the goals of the Master Plan which is to "Protect and preserve the quality of our water resources". The massive amount of water required would impact local wildlife and the wells of residents. Data centers also require diesel generators to operate during power shortages; these generators would be loud and create poor air quality for the local residents.

Data centers also draw large amounts of electricity, putting strain on the power grid. Howell Township already experiences many power outages throughout the year, and I cannot imagine a data center using large amounts of electricity would make that better. If a data center was to be constructed, significant investments in energy infrastructure would be required to ensure residents were not impacted by the power requirements of a data center. My name is Stephanie Nalepa-Hudge, an (almost) lifelong resident of Howell Township and current resident of Handy Township, living less than one mile from the proposed rezoning site. I am writing to express my strong opposition to the proposed rezoning of approximately 1,300 acres from Agricultural Preservation to Research and Technology for the development of a data processing facility.

Most importantly, this proposal directly contradicts Howell Township's Master Land Use Plan, which prioritizes "preserving existing natural resources and environmentally sensitive areas" through strategies such as protecting "wetlands, woodlands, and scenic vistas, and to get environmentally sensitive areas into permanent preservation" (Howell Township Recreation Plan, Chapter 2, p. 14). In contrast, the developer has claimed the project will "preserve the local character" and be buffered from view, despite admitting the size will be comparable to a Meijer supercenter (Stuart, 2025). The sheer scale makes such assurances implausible in the open agricultural landscape.

Beyond conflicts with the Master Plan, I—and many fellow residents—have significant concerns including, but not limited to transparency and pollution:

- 1. Transparency: Residents only recently learned of this proposal through limited local reporting (Stuart, 2025) and word of mouth. No clear plan has been presented, the purchasing company remains unnamed—described only as a "Fortune 100 technology firm" (Stuart, 2025)—and the long-term use of the additional rezoned acreage remains unexplained. Even Howell Township's water director, Greg Tatara, has stated there is not enough information to know whether current facilities could support the demand of such a center (Stuart, 2025).
- 2. Pollution and Nuisance: Typical sound levels in data centers average 80–90 dB(A), and can reach 96 dB(A)—levels comparable to concerts or music festivals (Tozzi, 2023; Sinclair, 2002). For residents living within close proximity, this would not be an occasional disturbance, but a constant 24/7 noise source. Such impacts clearly fall within the scope of Howell Township's Public Nuisance Ordinance No. 123, which prohibits actions that "annoy, injure, or endanger the safety, health, convenience, comfort, repose or other aspects of the public welfare" (Howell Township, 2001).

On a final, yet personal note, I grew up in Howell Township and this area has been close to my heart. When I think of my childhood, I am warmed by memories of natural forests, nearby fields, and agricultural surroundings. This is why, when my husband and I first began dating, I moved from Grand Rapids' inner city back to the City of Howell. I wanted our future family's quality of life to reflect the same rural values I experienced. My husband, who also grew up in an agricultural area near Ann Arbor, shared this vision. Shortly before our marriage in 2022, we moved to Fowlerville (Handy Township), hoping to provide our future children and our two dogs with land, natural resources, and a peaceful agricultural environment. We believed our dream was coming true as we now expect our first child in April 2026. However, we are gravely concerned that this data center will compromise the environment and quality of life we

envisioned. This is not the quiet rural living we anticipated when choosing to grow our family here and I am quite positive that this is a concern that many of those in our community share with us.

Given the lack of transparency, inconsistency with township preservation goals, and potential long-term harm to residents and infrastructure, I respectfully urge the Board and Planning Commission to reject this rezoning request.

Dear Members of Howell Township Board and Planning Commission,

My name is Lynn Romain, and I am writing to express my strong opposition to the proposed rezoning of over 1,100 acres from Agriculture Preservation to Research and Technology for the development of a data processing facility.

Concerns Regarding the Rezoning Proposal

Lack of Information and Transparency

One of my primary concerns about the rezoning application is the insufficient information and lack of transparency surrounding such a momentous change to Howell Township's current and future Master Plan. I am disappointed that a majority of the information I have received has come from Facebook posts rather than from official township communication. As a resident living within a mile of the proposed rezoning area, I am troubled by the limited time and information available to research and review all comments related to this proposed change. This lack of clear, accessible information makes it difficult for affected community members to fully understand the implications and participate meaningfully in the decision-making process. This type of noise could travel great distances and be heard from miles away, disrupting the peace and quiet that our community currently enjoys.

Environmental Impact

Based on my research, mainly conducted through internet searches, I have learned that facilities of this nature use considerable resources to operate. The ongoing demand for electricity and water to support data processing operations could result in significant consequences for our local environment and the broader community.

Dear Board Members,

I am writing to express my opposition to the proposed data center development in Howell Township.

1. Tax Breaks and Lost Revenue

While such projects are often presented as economic development opportunities, the reality is that our community will not see the promised benefits due to the significant tax breaks these facilities receive. A bipartisan Michigan law already grants major incentives to data centers. In 2024, legislation was passed exempting these companies from paying sales and use taxes on equipment and other infrastructure investments. On top of that, Industrial Property Tax Abatements under Public Act 198 of 1974 (see attached PDF) allow local governments to cut property taxes by up to 50% for 12 years, with additional exemptions available for equipment, improvements, and speculative buildings This means that all while the data center is consuming enormous amounts of land, water, and electricity, our community will shoulder the burden without receiving a fair share of tax revenue in return. Instead of contributing to schools, roads, and essential services, the company will benefit from layered tax breaks that shift costs onto residents and small businesses. I urge you to carefully weigh whether granting these incentives truly serves the long-term interests of Howell Township. A project that avoids paying its fair share in taxes cannot be considered genuine economic development.

2. Power and Influence:

I am deeply concerned about the level of influence one corporation could hold over Howell Township if the proposed data center project moves forward. In the developer's own materials, they claim the facility would generate more tax revenue than the entirety of Livingston County combined. While this may sound impressive, it terrifies me. Such financial dominance by a single company poses a direct threat to the balance of power in our community. How can I trust that

my one voice, one vote, and my neighbors' opinions will matter the same when weighed against the influence of a corporation that contributes more revenue than all other taxpayers combined? Once Howell Township becomes reliant on this company's dollars, every future decision; from zoning and infrastructure to schools and public services; risks being made with the company's approval as the first priority, rather than the needs of residents. Local government is supposed to serve the people, not a single business. Allowing one corporation to become more powerful than the collective community undermines the principles of fairness and democracy that Howell Township should stand for. I urge you to consider the dangerous precedent this project would set and to prioritize the long-term independence and integrity of our township over short-term revenue promises.

3. Water Impacts:

Huge quantities of water required for cooling: According to the Environmental and Energy Study Institute (EESI), large data centers may use up to 5 million gallons of water per day for cooling, equivalent to the consumption of a town of 10,000–50,000 people. Even "medium-sized" centers may consume over 100 million gallons per year just for cooling.

- Direct impacts on communities in less obvious ways: A University of Tulsa piece describes
 how many centers rely on potable (drinking) water for cooling, and in some cases, thousands of
 households or farms are affected. There are also instances where water usage is tied to well
 water depletion, reduced water pressure, sediment buildup, and other serious harms to local
 water supplies.

- The connection with artificial intelligence, rising power & cooling demands: As Al and high-performance computing grow, they require denser server arrays, more powerful chips, and greater cooling infrastructure. These demands drive up electricity usage and water usage simultaneously. Many new data centers are being built in locations chosen for cheap electricity —even if water is scarcer. Evaporative or water-intensive cooling techniques are frequently relied upon, particularly in climates or seasons where temperatures or humidity make cooling more challenging.

- **Evidence of harm in real communities**: The New York Times recently reported on a Meta data center in Newton County, Georgia, that uses roughly 500,000 gallons of water per day—about 10% of that county's total daily water usage. Neighboring households reported that after construction began, their wells have run dry at times, water pressure dropped, and the supply was so compromised that they've had to replace equipment and rely on bottled water.

• 4. Counterpoints to Township's Rezoning Justification (Page 25, "Data Processing")

The township's effort to rezone this project site to "Research and Technology" is being framed as if this facility were a simple, low-impact data center. However, the very language in the

developer's own application contradicts this narrative.

On page 44 of the 120 page packet available on your website, under the section on "**Data Processing**," the applicant lists an extensive array of materials and resources needed to operate the facility. This goes far beyond what the public might imagine when they hear the term "data center." The listed requirements highlight heavy industrial needs, including construction materials, specialized equipment, and infrastructure demands that align much more closely with **industrial-scale development** than with light "research and technology" uses.

This discrepancy raises several serious concerns:

- 1. Industrial in Nature, Not Research and Technology: The presence of large-scale material requirements, continuous cooling infrastructure, power supply reinforcements, and other industrial inputs is clear evidence that the operation is industrial in scale. Simply labeling it "research and technology" does not change the reality of the impacts.
- 2. Zoning Misclassification Risks: By forcing this project into a "Research and Technology" category, the township risks undermining the integrity of its own zoning system. Residents expect zoning to reflect real-world impacts. If a facility with obvious industrial demands can be shoehorned into "research and technology," then zoning protections for neighborhoods and the environment lose credibility.
- 3. **Precedent for Future Industrial Projects**: If approved, this rezoning sets a dangerous precedent. Other developers will point to this case and argue that their industrial projects should also qualify under "Research and Technology." Howell Township could open the floodgates for inappropriate, large-scale industrial uses in zones never meant to accommodate them.
- 4. **Public Trust and Transparency**: The mismatch between the township's framing ("just a data center") and the developer's own words (acknowledging the industrial nature of the inputs and operations) erodes public trust. If the township is willing to stretch definitions to approve this project, residents have no reason to believe future zoning decisions will be handled honestly or with community protection in mind.
- 5. **In summary:** What is being presented as a "simple data center" is, in reality, an **industrial facility** requiring extensive infrastructure, resources, and material inputs. The township's attempt to rezone to "Research and Technology" is misleading and undermines both zoning integrity and public trust. If this project is industrial in nature, it should be treated, reviewed, and regulated as industrial not disguised under a lighter classification to ease approval.

5. Do Not Vote on Sept 23rd 2025 for the sake that Howell Township could Experience Extensive legal Action:

Availability of the materials for review is explicitly required by statute for the notice to be valid

- Statutory Language: Under MCL 125.3401(9)(d) (Michigan Zoning Enabling Act): The notice of ordinance adoption shall include: "The place where and time when a copy of the ordinance or amendment may be purchased or inspected."
- This means:
 - The notice must tell the public where and when they can review or obtain the ordinance or amendment.

• If the text is not yet available for inspection at the time of notice, the notice is arguably defective because it cannot truthfully state where and when the text can be reviewed.

Implication:

- If the municipality issues a notice without making the proposed text available for review, it likely violates MCL 125.3401(9)(d).
- Courts have held that strict compliance with notice requirements is mandatory. In *Montrief v. Macon Twp. Bd. of Trustees* (2023), the Court of Appeals invalidated a zoning amendment for failure to comply with statutory notice provisions, reinforcing that procedural defects can void an ordinance.

Practical Effect

- A notice that says "materials available for review" but does not actually make them available could be challenged as misleading and noncompliant.
- A notice that omits any reference to availability is facially defective under the statute.
- Howell Township did not have the packet available until September 18th, 2025. This means you
 have opened up this township to not only face legal action if you vote yes from the people, but
 also if you vote no from the land owners/ investors. While this letter is in opposition to the data
 center wholeheartedly. I HIGHLY ENCOURAGE A NO VOTE ON SEPT 23rd TO AVOID ANY AND ALL
 LEGAL ACTION THAT COULD COST US THOUSANDS IF NOT MILLIONS OF DOLLARS.

6. Better Alternatives for the Community

Instead of rezoning this property for an industrial-scale data center, Howell Township could use this land in ways that genuinely enrich our community. A multi-use recreational facility, such as: a dog park, disc golf course, pickleball courts, or softball and baseball complex. These would provide healthy outlets for families, youth, and seniors, while preserving the rural and small-town feel that defines Howell. Parks and recreation facilities generate modest but reliable revenue through concessions, tournaments, and events, while ensuring the land remains open, welcoming, and beneficial to everyone. Unlike a data center, which isolates resources for private profit, a recreation complex would build community pride, improve quality of life, and strengthen Howell Township's identity for generations.

In summary:

The tax incentives strip away the very revenues that could offset the community costs of hosting a data center. We should not give away long-term tax revenue, land, and natural resources for a project that provides minimal jobs, risks environmental strain, and undermines the financial well-being of our township. Instead, Howell Township should invest in land uses that benefit residents directly, protect our rural character, and provide sustainable community value.

I respectfully urge you to reject this project and instead pursue development opportunities that put people and community first.

I'm writing this email to express my concern over the potential rezoning of the Van Gilder Farm and other parcels to Research and Technology with the intent to sell to a data center developer.

There are a number of concerns with these type of developments as I am sure you are aware (water, power, noise, e-waste, etc) so I just want to focus on water and some of the communications that I have received through my various community roles.

One stakeholder approached me requesting support and told me that they plan to get their water from the City of Howell. A different, and much larger, stakeholder mentioned that they're going to talk to the Village of Fowlerville about their water. I do not believe that either of those entities have the ability to supply the amount of water that these data centers use each and every day. Additionally, both of those municipalities utilize wells drawing from the same groundwater aquifers as local residences and farms. So whether the water is directly taken out of the ground below the property, or from the surrounding areas, it will have a significant negative impact on the local water supply.

Additionally, when considering the overall approach of this development, if something is truly a good idea and a value to the community it doesn't usually require the developer to provide pre-written talking points, "sales pitches" focusing nearly entirely on the financial benefits to entice municipalities and government agencies to fill out pre-drafted support letters, or utilize NDA's to protect their reputations just to convince people that it's a good idea.

It is clear from comments made by multiple stakeholders, including Mr. Van Gilder in his media interview, that the land owners intend to no longer farm that land one way or another. And it is not my intention for you to tell them that they cannot sell their families land, but why do they get to permanently alter the community they are choosing to leave.

Please remember that the majority of the people who live in this area, whether they grew up here or moved here, did so because they love this community and its agricultural history.

I am writing to express my strong opposition to the proposed rezoning from Agricultural/Residential to Research and Technology of the large parcels between Howell and Fowlerville. I am a concerned resident of Fowlerville and believe that this development would have significant negative impacts in and around our community, environment, resources, and overall quality of life.

Many of us came to this rural area and built homes and decided to raise our families in cities like Fowlerville and Howell with intentions of small-town feel. The farmland attracted so many growing families to the community based on the farmland being designated for Agricultural/Residential. Why can we not keep it that way? Although these jobs are important, they do not match the high salaries that have been promoted.

I moved to this area and decided to raise my family here because I loved the community and its agriculture history. Please do not take away and change the landscape of our beautiful community.

My name is Jeannie Matovski. I'm a lifelong resident of Howell (born here in 1983) and an elementary school teacher. I love this town, its history, and its people. I am strongly opposed to the proposed data center development that would convert over 1,000 acres of farmland into industrial use. I believe it poses serious, measurable risks to our water supply, environment, and quality of life.

Water Supply & Environmental Risks

1. High water demand for cooling

- Data centers require large amounts of water to cool servers. Some large "hyperscale" data centers use hundreds of thousands of gallons per day simply for cooling. <u>Department of</u> <u>Engineering Science+3Dgtl Infra+3Environmental and Energy Study Institute+3</u>
- To illustrate, just one medium-to-large data center might use 5 million gallons of water per day — roughly equivalent to the water use of a town of 10,000–50,000 people.
 Environmental and Energy Study Institute

2. Strain on local water resources

- Howell and the surrounding area depend on groundwater, local wells, and surface water (streams, rivers) for drinking water, irrigation, and daily use. Large withdrawals by a data center could reduce water levels, lower pressure in wells, and lead to water shortages, especially during dry spells.
- If water is drawn from the same aquifers we use, there is a risk of overuse, which could lead to drop in water tables, contamination risk, or wells going dry for residential properties.

3. Loss of water filtration and recharge

- Farmland, soil, wetland patches, and natural vegetation help with water infiltration when it rains. They allow rainwater to soak into the ground, replenish groundwater, and naturally filter pollutants. Removing 1,000+ acres of farmland means increasing impervious surfaces (roofs, paving, parking lots) which sharply reduce infiltration, increase runoff, and reduce recharge.
- Reduced infiltration also means runoff carries more sediment, nutrients (nitrates, phosphorus), agricultural chemicals into streams and lakes, degrading water quality.
 Michigan studies show that wetlands and conservation practices on farmland significantly

reduce nutrient load and improve water quality. <u>Ag & Natural Resources College+2Ag & Natural Resources College+2</u>

4. Impact on storms, floods & drought resilience

- Natural farmland and wetlands moderate water flows during heavy rainfall. They absorb
 and slow down stormwater, preventing flash flooding. If large tracts are converted to
 industrial use, stormwater runoff will increase, flood risk could rise downstream, and soil
 erosion could worsen. Ag & Natural Resources College+1
- Conversely, during dry periods or droughts (which are expected to become more frequent with climate change), the lack of natural recharge will make water scarcity worse.

Community & Health Impacts

- If water tables drop, residents may face higher costs digging deeper wells or treating water to make it safe.
- Water quality degradation might lead to algal blooms, unsafe drinking water, or harm to local fisheries or recreation (rivers, lakes).
- Increased costs for water utility systems (more pumping, treatment).

Conclusion

Howell is not just a place on a map—it is home. We depend on healthy land and reliable water to raise our children, farm our fields, maintain our natural beauty, and keep our community safe and sustainable. A project of this scale threatens those things.

I urge you to consider these data-driven risks carefully, demand full environmental impact assessments (especially hydrological ones), and protect our farmland, water, and way of life.

Dear Members of the Board and Planning Commission,

As residents of Howell Township, we strongly oppose the proposed rezoning of the agricultural land. For the reasons below:

- 1. The proposal goes against the Howell Township's Master Plan. Residents like us move to Howell for the rural atmosphere with the understanding it will remain. We appreciate that landowners have the right to sell their property, but it should be within the confines of the Master Plan. If it cannot remain in use for agriculture, we would prefer to see it used for lower cost (starter houses) for young families.
- 2. Environmental impact, loss of wildlife, and harm to humans. Not only will this push out wildlife, but it will affect our night sky with light pollution along with noise pollution. Air pollution generated by data centers has also been linked to serious health risks to humans such as asthma, heart attacks, cognitive decline, and premature death. A 2025 study estimates that air pollution from US data centers caused \$6 billion in public health damages in 2023, with projections reaching \$10 billion to \$20 billion annually by 2030. An executive order from the Biden administration explicitly acknowledges the public health risks, requiring new data centers to be in areas where air quality meets national standards and cancer risk from pollution is at or below the national average. This alone seems to reason enough to not allow the requested rezoning.
- 3. Enormous amounts of water usage and potential for contamination. Wastewater and heated discharge are a threat to aquatic life. Also, there is credible reporting by local governments and environmental groups warning Michigan to fully consider whether aquifers or water utilities can support data center's 1-5 million gallons/day. Howell's existing water/wastewater infrastructure shows capacity of 1.8 MGD. Also, the claim that the data center will not affect local wells has not been proven. Depending on how much water it draws, how close wells are to water tables used, the geology, rate of recharge, etc., it could affect local wells. Local documents show the township is working on wellhead protection rules, which is a sign this is a recognized risk.

- 4. **Energy demand and grid pressure.** We already face loss of electricity with frequent outages in Howell Township. Data centers require a massive amount of electricity which will strain our already outdated grid while increasing the demand. Rising demand without increased supply will certainly impact the cost of electricity. Evidence shows that large electric loads can place strain on the systems, which sometimes causes higher costs either via upgrades or passing costs to ratepayers.
- 5. Reduced property values to surrounding neighbors due to the above-mentioned items. Also, a data center would not bring the proposed tax base nor the new jobs. The data center is getting tax incentives which is why they are looking to build here. The permanent new jobs projected is approximately fifty. Not near enough return on investment for 1,300 acres. The skilled jobs will not likely go to local Howell residents either.

We respectfully request the Board and Planning Commission deny the rezoning request and protect our community.

I am writing not only to express my personal opposition to the proposed rezoning request of the 19 parcels east of Handy Township along Marr, Fleming, Warner, and Owosso Roads for a data center, I am also writing to share with you the significant community opposition as evident in the more than 1,300 resident petition signatures gathered in less than 72 hours via an online petition.

As of 4:00 PM this Tuesday, September 22, there are 1,338 petition signatures opposing this rezoning request, with more than 82% verified residents of Howell or Fowlerville, both communities that the proposed rezoning will significantly impact. You can access the online petition to review the number of verified signatures and relative locations via this link: https://chnq.it/2YCyPRhqnt.

In addition to the incredible lack of transparency around this proposal, from the withholding of the identity of the corporation to the vague, unsubstantiated claims outlined by the applicant in the packet memorandum, the proposed rezoning raises many concerns for me and other residents:

1. **Exorbitant Water Usage:** Fresh, potable water is a finite resource on a human time scale that can be depleted much faster than it is replenished. Aquifers that fill over thousands of years can be emptied within a single lifetime. Data centers use water on an unimaginable scale (up to 5 MGD) that

is not sustainable for the long term. If residents don't have a sustainable water source for generations to come, then we have nothing - a couple hundred jobs or a potential increase in tax dollars won't matter. You can't drink tax dollars.

- 2. **Pollution and Health Concerns:** Massive amounts of fossil fuels will be burned to sustain this data center, resulting in CO2 emissions that will harm local residents and our children. There are more than 5 schools within a 5-mile radius of the parcels and more than triple that number within 10 miles of the site. Data centers also generate tons of e-waste and if not disposed of properly, toxic chemicals can end up in the environment and in our water supply. These concerns are not illegitimate, as we've already seen other corporations pillaging Michigan's natural resources (e.g. Nestle bottling and selling billions of gallons of our ground water for free) and poisoning our environment (Tribar Manufacturing dumping 10,000 gallons of hexavalent chromium into the sewer and thereby, the Huron River system).
- 3. **Increased Costs for Residents:** There is mounting evidence that the massive amounts of electricity used by data centers result in increased energy bills for residents. According to Wood Mackenzie, a data and analytics firm, at least 20 proposed or effective electricity rates for data centers across 16 states are not sufficient to cover power costs. Another independent analyst, Monitoring Analytics, found that 70% of the increased electricity costs nationally last year were the result of data center demand. (AP News, Aug 2025)

For these reasons and many more, residents are strongly opposed to the rezoning of these parcels and do not want a data center built in our beautiful, rural community. If we amend the ordinance text to include research and technology rezoning, this could open the door for many other data center proposals that will forever change Howell and surrounding areas. We have the opportunity to choose who decides the fate of our community - a mega corporation that refuses to disclose its identity - or those who live here, work here, raise their families here, and love Howell.

I urge you to consider the generational impact of this rezoning request on our community and our children. On behalf of myself and the more than 1,300 others who spoke up to make their voice heard via this petition, I urge you to deny this rezoning application and instead choose the health of our neighbors and children, our clean air and water, and our way of life over their empty promises.

NOTICE TO TRUSTEES AND PLANNING ADMINISTRATION

Please accept this email as my formal public comment for all three petitions scheduled for the September 23, 2025 Planning Commission hearing: PC2025-19 (rezoning RSC to Industrial), PC2025-20 (rezoning AR to RT for a proposed data processing facility), and PC2025-21 (text amendment to Article 5 – RT Zoning definitions). My comments are intended to apply to each of these related zoning amendments

Howell Township Public Hearing – September 23, 2025

Good evening. I am a beneficiary in this community and respectfully submit this Notice to Trustees summarizing the Township's own Master and Recreation Plans and reminding trustees of their oath-bound duties. I offer this in peace to help the planning commission honor the public trust.

By oath of office, sworn to uphold the Constitution of Michigan and the United States, each officer has accepted the position of trustee. *That oath is itself a trust instrument*, regardless of declared emergencies. In law and equity, public office is a public trust; the beneficiaries are the people, and the res of the trust is the land, wildlife, water, and community placed in your care.

Anderson's Dictionary of Law tells us that for purposes of inheriting or receiving a beneficial interest, life begins with conception.

In the same way, the people of Livingston County carries a beneficial interest in this land and in this decision. From the moment each of us chose to dwell here, to raise families here, to make our abode here, and to invest our life's energy here, that beneficial interest was conceived and accepted. And in trust law, acceptance need not be formal — the Restatement (Second) of Trusts, §36, affirms that acceptance may be shown by conduct. By our very presence, by our use and enjoyment of this community, we have lawfully vested ourselves as beneficiaries of the res.

We came because your own plans, your own websites, and your own promises spoke of rural character, natural resources, wildlife, and farmland preservation. That is the life of this community. It has already begun. It is living, vested with the life-source energy of its people, and it is entrusted to you as trustees. To turn from those promises now is to disregard the beneficiaries' accepted life interest, conceived in trust and poured into this community.

The Township's own Master Plan and Recreation Plan are published trust instruments.

Key Citations from the Master & Recreation Plans

- "Maintaining the rural character of the community is considered critical by residents and Township leaders alike."
- "Goal: Encourage the use of open space in all developments for a useful purpose and preserve or conserve natural open space, including wetlands, woodlands and flood plains."

- "Goal: Preserving existing natural resources and environmentally sensitive areas. Strategy: Protect wetlands, woodlands, and scenic vistas. Get environmentally sensitive areas into permanent preservation."
- "Public survey: 91% of residents indicated that protection of natural resources was important or very important."
- Chapter 7: "Open space and scenic beauty are among the greatest assets in Howell Township. The protection of open space and natural resources will help to maintain the quality of life..."
- Chapter 8: "The success of this Master Plan depends upon citizen understanding and participation in land use, zoning, and development decisions."
- Chapter 8: "Implementation will require active involvement of Township officials, residents, and the private sector working together to uphold the vision of the Plan."

Future Land Use & Beneficiaries' Enjoyment

The Howell Township Master Plan itself defines the **res of this trust**: the farmland, open space, and rural character that make this community what it is. Its *Future Land Use Strategy* declares that land use decisions must preserve farmland, open space, and most importantly the community's **quality of life and character**. This is recognition that the beneficiaries — the people of this Township — hold the right of enjoyment in the land, not merely the private owners seeking profit from sale.

The Plan further designates **Recreation and Preservation Areas**, with the express purpose of maintaining open space, protecting wetlands, woodlands, and groundwater recharge, and providing trails, parks, and play areas for the public. These are not commodities for speculation — they are **assets of the trust estate**, dedicated to the beneficiaries' use and enjoyment.

And in **Chapter 8 – Implementation**, the Plan reminds trustees that *its success depends upon citizen understanding and participation in land use, zoning, and development decisions*. That is written notice that beneficiaries must be included before the res can be altered. Any rezoning that disregards their voice is a breach of both the Plan and the public trust it embodies.

We recognize and respect the right of private landowners to sell their land. Yet the sale at issue here is not a simple transfer within its intended use as farmland. It seeks to transform the land from agricultural preservation into industrial exploitation. That change of use alters the very res of the trust — and for that reason the beneficiaries' voices must now be heard. Even though the farmer owns it, the *use* is limited because the community — as beneficiaries — has an equitable interest in how land use affects natural resources, rural character, water, traffic, wildlife, etc.

As Lewin on Trusts makes plain: a trustee "cannot place his own interest, or that of third parties, in conflict with his duty to the beneficiaries."

That is the line trustees here must walk. The trust res has been named. The beneficiaries' will has been declared. To rezone against these principles is to abandon the trust and forsake the oath.

This truth is echoed in scripture. Christ said, "Follow me, and I will make you fishers of men." And they straightway left their nets and followed him (Matthew 4:19–20). The call required them to leave behind their nets — their livelihood and attachments — to answer a higher duty. Trustees of this Township are under the same call: to leave behind the nets of corporate persuasion or individual gain and follow the higher duty owed to the beneficiaries.

A trustee may not serve two masters. By your oath and by the plans you adopted, you are bound to one: the people and the land of this Township. Any act contrary is breach of trust, for which trustees bear liability.

This reminder is given in peace: protect the farmland, protect the wildlife, and protect the res entrusted to you.

To the beneficiaries — you are heard, you are seen, and you are acknowledged. Your presence, your voice, and your life's energy have already vested your beneficial interest in this land.

To the landowner — we honor your right to sell, but the proposed change of use does not align with the Master Plan or the will of the beneficiaries. Your stewardship until now has been part of the life of this community, and that is respected.

To the trustees — we appreciate your sacred service. Yours is not an easy office, but it is an office of trust. Tonight is an opportunity to show that fidelity to the oath still carries weight, and that loyalty to the beneficiaries remains your guiding star.

And to the corporation — we acknowledge you only as a *thing*, an outsider to the trust relationship. You are not a living soul, you do not dwell here, you do not walk these fields, you do not raise children here, nor do you breathe the air we breathe. Whatever profit you may seek, it cannot override the equitable use of the land, or the Master Plan, or the will of the beneficiaries. Those living interests supersede any corporate claim.

Let us all, then, remain in peace. Let us choose what preserves life, what honors promises, and what strengthens trust.

The Howell Township Master Plan is clear that Agricultural Preservation areas are to remain rural and farmland protected, while low-density residential should be kept compatible with neighborhoods. This proposal does the opposite — it converts over a thousand acres of farmland into an industrial-scale data center, places substations and generators alongside homes, and stretches well beyond the focused growth corridor the Plan envisioned near Grand River and I-96. In short, it conflicts with the Master Plan's core principles of farmland preservation, neighborhood compatibility, and natural resource protection.

To Whom it May Concern:

My husband, Tim, and I very recently learned about potential plans to build an AI data center in Howell and the pending proposal to change the zoning on several parcels in Howell Township from Agricultural Residential (AR) to Research and Technology (RT) to accommodate this future project. We are alarmed and concerned about this pending change.

Having only recently moved to the surrounding area, we are still learning how to find information like this about pending changes, and we were first notified through a community group on Facebook just a few days ago. However, it does sound to me like one of the concerns other citizens have is that there has not been sufficient notice to the community given the size and potential impact of a project like this, and there has also been limited information provided about the project in terms of its impact to the community. My husband and I echo these thoughts based on the very limited information we were able to find on such short notice.

While we are technically residents of Putnam Township and do not have a vote in Howell, we do believe that this project could potentially impact us in a large way, as Howell is only a few minutes down the road. If I were to vote on this issue, my vote today would be to deny the zoning change request and ask that the Township not move forward until a full report showing the expected net benefit of an AI data center to the Township has been made available to the public for review. In such a report, I would want to see the following information:

- total net acres to be consumed by the project
- total expected living-wage jobs that will be produced by the data center
- the source of water to be used for cooling at the facility (natural origin plus how much will be recycled versus drawn on a daily basis)
- the source of electricity to be used for operating the facility (whether from the power grid alone or if on-site nuclear power or other sources of energy would be used)
- a measure of noise pollution that could be produced by the facility
- the amount of revenue generated per year by Howell Township as a result of permitting and tax revenue from this project AND how that revenue will be used by the township to benefit the surrounding community.

I believe that the township owes an explanation of the above details to the community before any action is taken to change the property zoning, especially when changing the zoning of such a large area of land would potentially pigeon-hole the township for future development, should the final project not be approved. What other projects would potentially be approved in its place on a large area of property zoned Research and Technology, should the AI data center not come to fruition?

What is the outlook on Howell being able to market to other businesses in the industry in order to fill land with the changed zoning? Could the township be better benefitted by welcoming businesses from other industries?

As new property owners in Livingston County, our primary private concerns with this project are:

. How will it affect our property value in the long-term?

- Will there be plenty of good jobs in the area for potential buyers of our home in the future?
- Will the town of Howell become an eyesore or a source of noise pollution, making it an unfavorable place to live, shop, work, or go to school?

• Will our electricity remain affordable?

I understand that DTE raised its rates significantly this past spring. Already, we are paying
the highest electric bill we have every paid in our middle-aged adult lives, and with costs
rising everywhere, we want to protect what limited disposable income we have left.

• Will nuclear reactors be added within a "danger zone" area of our home?

This was something we considered when purchasing a home in southeast Michigan. We
are strongly against living within an hour of any sort of nuclear reactors due to the
potential threat to health and life in an emergency situation, and I hope that Howell will
not make us regret our decision to move right down the road.

We have read that the plans for this project include buildings that will blend with the surrounding environment and landscaping that is aesthetically pleasing. We also understand, although we do not know the exact amount, that a project of this size would bring considerable revenue to Howell Township. We are not above understanding that there are potential benefits to the project and potential solutions to some of the concerns listed above. However, we are generally opposed to Al data centers because they tend not to bring significant employment, tend to use a lot of valuable resources, and generally do not benefit the immediate communities in which they are located. In our opinion, this project is likely better suited for a very rural area that has limited potential for other future development. We will leave it to the township and its citizens to hopefully move forward thoughtfully and not make any decisions that our community will regret for years to come.





Message to township: The FAQ's claim of "millions for schools" is contradicted by Michigan's

The request to rezone these parcels from Agricultural Residential (AR) to Research and Technology (RT) zoning carries significant risks for the community, environment, and surrounding residents. Reasons for Opposition

- 1. Per Article XXIII and Section 23.02, the Board must determine consistency with the Master Plan before approving any rezoning. The Howell Township draft Future Land Use Map designates the subject parcels as Agricultural Preservation. The Township Master Plan states the following regarding the Agricultural Preservation future land use classification: "These areas are intended to remain rural. These areas are intended to maintain the existing agricultural lands in the Township. Housing in these areas should be on large lots to keep density low. The area planned for AP includes the majority of the Township. In addition to preserving large swaths of active farmland that helps to support the agricultural industry in the community, these areas also help to maintain the existing character that many Township residents identify as what they feel is most important about the community." Therefore the zoning request from AR to RT conflicts with the plan and should be denied, or the plan should be amended first with full public process.
- 2. Environmental Damage and Loss of Wildlife Rezoning to RT opens the door to large-scale industrial and data-center type facilities that destroy farmland and wildlife corridors. Michigan environmental groups warn that these projects eliminate habitat, increase impervious surface runoff, and can discharge heat or pollutants into waterways (Huron River Watershed Council).
- 3. Water Use and Potential Contamination Data centers and similar technology facilities consume massive amounts of water. Reports show average centers use over 1 million gallons per day for cooling, straining aquifers and municipal systems (Bridge Michigan). Wastewater and heated discharge further threaten aquatic life and groundwater integrity.
- 4. Energy Demand and Grid Reliability Michigan already faces reliability issues with frequent outages. Data centers impose enormous electrical loads that worsen strain and can degrade power quality for nearby residents. A University of Michigan policy study warns this level of energy demand

forces utilities to keep fossil plants running or build new ones, undermining clean-energy goals (STPP Ford School).

5. Property Values and Community Impact - Property values near industrial technology projects typically decline due to noise, glare, traffic, and degraded surroundings. While developers promote supposed tax benefits, Michigan's nonpartisan fiscal analysis projected over \$90 million in state and local tax revenue losses by 2065 tied to data center incentives, with limited job creation (Planet Detroit). Local residents bear the costs while benefits largely bypass the community. Request to the Board

Given the scope of this petition, I respectfully request the Board and Planning Commission to deny rezoning from AR to RT for the subject parcels. At minimum, the township must require: Issue

Proposed Requirement

Law/Ordinance/Regulation Be Adopted/Enforced

Environmental impact, water use, wildlife, habitat protection

Require a full Environmental Impact Assessment (EIA) prior to rezoning, covering water draw, wastewater discharge, wildlife habitat, effects on wetlands, heat discharge, etc.

Michigan Zoning Enabling Act, Act 110 of 2006 (MCL 125.3201 et seq.) gives townships power to regulate land uses to protect public health, safety, welfare, natural resources and conserve natural resources and energy. (Michigan Legislature) Also requires compliance with state/federal wetland protection laws (e.g. Clean Water Act) and local wetland ordinance if present. Include Michigan Public Act(s) for enterprise data centers (e.g. House Bill 4906 / Public Act 207 of 2024) which require data centers to adopt practices to mitigate negative environmental impacts, including water reuse, renewable power, etc. (Michigan Legislature)

Electric infrastructure & energy demand, grid strain

Require proof of adequate electric capacity, reliability, and no degradation of service to existing customers. Also require binding contracts or rate structures so other ratepayers do not subsidize utility upgrades.

From the report What Happens When Data Centers Come to Town? (U of Michigan Ford School & Michigan Environmental Justice Coalition) suggesting that states/localities should mandate energy audits, renewable energy integration, enforce transparency in energy usage, regulate utility rate-hikes to prevent cost-shifting. (stpp.fordschool.umich.edu) Also Michigan legislature is considering legislation (and some passed) that requires data centers to draw from municipal water systems, and to ensure residential energy customers are not subsidizing lower rates for data centers. (Planet Detroit) Water usage and potential contamination

Require water-use plans, including sources (surface, groundwater, municipal), treatment of wastewater or cooling discharge, reuse or recycling of water, limit on heat discharge, and monitoring/reporting. Adopt ordinance to require these for any RT zoned development.

Public Act 207 of 2024 / HB 4906 includes provisions encouraging conservation, reuse, recycling of water, use of reclaimed water, partnering with utilities, etc. (Michigan Legislature) Also the "What Happens When Data Centers Come to Town?" report advocates such requirements. (stpp.fordschool.umich.edu)

Noise, lighting, traffic, externalities, property value protection

Adopt local ordinances or update the zoning code to include noise ordinances (decibel limits), lighting control, traffic mitigation (hours, truck access), buffer zones, setbacks, screening, etc. Also define property value protection (ensuring neighboring residential properties are not unduly harmed). Michigan's Noise-Related Statutes allow local control via ordinance, including limiting outdoor decibel levels. For example MCL 691.1542 covers rules or regulations adopted by the state for limiting noise levels in an outdoor atmosphere. Local noise ordinances (such as those in Clio, Michigan, or Orleans Township's Noise Control Ordinance) show examples of noise disturbance definitions and

enforcement. (Michigan Legislature) Also under Michigan Zoning Enabling Act, zoning ordinances must be made with "reasonable consideration ... for the conservation of property values." MCL 125.3203(1) mentions "conservation of property values and natural resources." (Michigan Legislature) Transparency, reporting, enforceable conditions

Require binding, enforceable conditions in the rezoning decision, with ongoing reporting (energy use, water use, noise, outage impact). Also require that site plan approval includes conditions; require special land use / performance guarantees.

Michigan Zoning Enabling Act, Act 110 of 2006: sections concerning Special Land Uses (MCL 125.3502) and Site Plan Submission and Approval (MCL 125.3501). These allow the township to impose conditions, enforce compliance, require guarantees, etc. (Michigan Legislature) Also Public Act 207 / HB 4906 requires that data centers applying for tax exemptions must maintain certain reporting to the MSF (Michigan Strategic Fund) including water, energy usage, and invoices. (Michigan Legislature)

Conclusion

In considering File # PC2025-20, please note a nearly identical rezoning request in nearby community Saline Township that was recently denied on September 11, 2025, after residents and officials cited the same concerns outlined above. The petitioner's request for the subject parcels not only conflict with the township's master plan and future land use map (which emphasizes conserving agricultural land and sensitive resources, and weighs against converting large tracts of farmland to RT for high-intensity technology uses) but jeopardizes our communities farmland, water, wildlife, electric reliability, and property values. These risks far outweigh any speculative economic benefit.

I urge the Township to stand with its residents and reject this rezoning request.

I am writing to express my deep concern and disagreement with the attached proposal to rezone property from Agricultural Residential to Research and Technology. I have lived in Howell for 33 years, and my family has lived here for 40 years. We moved here for the tranquility and peacefulness. Constructing a data center in Howell would ruin this tranquility and peacefulness for current residents and future generations alike.

As seen with other data centers across the country, the initial construction of the facility may provide jobs, but after construction is complete data centers usually only employ 50-100 people (Data centers bring money to small towns. But do they also bring jobs? : NPR). This low number of permanent jobs does not justify the environmental impact of this project. The director of the Marion Howell Oceola Genoa water plant has stated that he does not even know if our current water system has the capacity to maintain this project (Howell Township could be home to Michigan's largest data center — The Livingston Post.com). With water and electricity rates already rising, this data center would put additional strain on our already fragile and overstretched water supplies and electrical grids, raising rates even further. The state of Michigan also experienced a drought this summer, and we have seen in other areas of the country that data centers exacerbate droughts (Drought-stricken communities push back against data centers). The land proposed to be rezoned should be kept as farmland, especially as demands for agriculture will not decrease any time soon.

Please reconsider the rezoning of this land to help protect the precious resources and community of Howell.

Reasons a Data Center is Harmful to Howell Township and not in the best interest of residents:

- 1. Environmental Disruption and Threat to Wildlife The proposed data center would severely disrupt the natural environment. This could displace wildlife, fragment their habitats, and threaten the survival of vulnerable species. Research from MIT underscores how data centers contribute to underrepresented ecological impacts, including habitat fragmentation and biodiversity decline due to land use and associated pollution.
- 2. Strain on the Electrical Grid -Data centers are notorious for their immense energy consumption, often requiring massive amounts of electricity to power servers and cooling systems. This would place an unsustainable burden on Howell Township's electrical grid, potentially leading to higher energy costs for residents, increased risk of power outages, and a reliance on fossil fuels that undermines our community's efforts toward sustainability. The grid's stability is critical for our homes and businesses, and a data center's demands could jeopardize this. Studies show that Al-driven data centers are exacerbating energy demands through unsustainable sources like coal-fired plants, with global expansion projected to consume energy equivalent to entire countries. FracTracker's national tracker further reveals the pollution and public health risks tied to this unchecked growth in energy use.
- 3. Depletion of Water Resources Data centers require substantial amounts of water for cooling purposes, which could strain Howell Township's water supply. This is particularly concerning in a region where water resources are already carefully managed. Excessive water use could deplete local groundwater, affect agricultural needs, and limit availability for residents, posing a direct threat to our community's long-term water security. According to the Environmental and Energy Study Institute (EESI), data center water usage mirrors their energy demands and carbon emissions, with hyperscale facilities consuming millions of gallons annually—equivalent to the needs of thousands of households. Additional reports from AKCP highlight how this contributes to drought exacerbation and habitat loss in vulnerable areas, such as the American West, with similar risks applicable to our local ecosystems. Environmental groups in regions like Wisconsin have raised alarms over Al data centers' projected water withdrawals, which could rival municipal supplies.

- 4. Noise Pollution The constant hum of cooling systems and other equipment in data centers generates significant noise pollution, which would disrupt the peace and tranquility of Howell Township. For both residents and wildlife, this noise could cause stress, alter behavior, and diminish the quality of life in our rural community. A study published in Global Transitions further documents how data centers produce substantial noise from HVAC systems and diesel generators, impacting human health and nearby ecosystems through chronic exposure. Gradient Corporation's analysis of large data centers confirms this as a key community concern, alongside water and power issues.
- 5. Additional Community and Environmental Impacts Beyond the above concerns, data centers can lead to increased traffic from construction and operations, further air pollution from backup generators, and the potential for hazardous waste from equipment maintenance. These factors would degrade the quality of life for residents and harm the natural beauty that makes Howell Township a desirable place to live. NPR reporting on resident push back in Virginia illustrates how data centers' intensive resource demands have sparked widespread opposition due to their environmental toll. Net Zero Insights notes that even water-cooled variants, while marginally more efficient, still emit significant carbon and strain resources.

In conclusion, the construction of a data center in Howell Township would have far-reaching consequences for our environment, wildlife, and community resources, as evidenced by these peer-reviewed and organizational studies. I urge you to prioritize the long-term health of our township and reject this proposal in favor of preserving our natural environment and community well-being. Please vote NO.


out of character with the surrounding community and the county. And as I understand it, it is not something that the Howell Township master plan has ever contemplated.





And it's not uncommon to see other DCs being built where one already exists. We urge you to vote NO on the rezoning request. We want to keep our area rural!
